ACCELERATED MEDICINE COURSE

(A101) How to apply (2017/18 Entry)

The application process for the Accelerated Medicine course (A101) at Oxford consists of (1) this supplementary application form, (2) the UCAS application and (3) taking the Biomedical Admissions Test (BMAT). Please note that all application material should be submitted electronically and by the deadline of 15 October 2016.

1. Supplementary application form - submission deadline 15 October 2016

This application form collects some additional information which is not on the UCAS application:

Personal application details

Please ensure that you enter the same information here as on your UCAS application. You must register for the BMAT (see below) before submitting this application form. If you wish to apply for deferred entry, please change the entry date at the top right corner of the form.

• Higher Education and qualifications

Include details of your tertiary qualifications (degrees) here. Please use the Qualifications section of your UCAS application to provide information about your secondary qualifications (e.g. A-levels).

Employment history and Current position

Please give brief details of any occupational experience, and outline your current position (e.g. studying, working).

• Academic referees (please name three only)

Please give the names and positions of three referees, at least two of whom should be familiar with your most recent academic performance.

Your supplementary application form should be supported by the following documents:

Personal statement

Please provide a brief statement in PDF or Word format (of no more than one page) of your reasons for wishing to undertake medical training and for wishing to study on this course. Please make sure your name and course you are applying for (A101) is entered on this statement.

Academic transcript

Please provide an electronic copy of your transcript or other detailed official academic record of your higher education attainment to date.

Proof of English proficiency

If your native language is not English, please provide evidence of your English proficiency (see www.admissions.ox.ac.uk/enregs for further information).

2. UCAS application - submission deadline 15 October 2016.

Your UCAS application **must** be completed online at <u>www.ucas.com</u> by 15 October 2016. You should enter the institution code for Oxford (O33) and the course code (A101), and then select your college of first preference, from those listed at <u>www.medsci.ox.ac.uk/study/medicine/accelerated/colleges</u>. For this course you may also name a second college preference in the 'Further Details' section. If you wish to make an open application, select campus '9'.

Please note that we assess only the separate Personal Statement and three references you send in with this application form, not those on the UCAS application. You may, if you wish, use the same statement and/or one reference on your UCAS application if you are applying to other universities.

3. BMAT - standard registration deadline 1 October 2016

All applicants are required to take the BMAT. Further details, including the registration procedure, are available on the BMAT website (www.bmat.org.uk).

Submitting your application

Your application form only and supporting materials should be emailed as a PDF form, with Word or PDF attachments, to Ms Marion Edney (accelerated.medicine@admin.ox.ac.uk) no later than **15 October 2016**. Please take care to include your candidate name in each document. Ms Edney will acknowledge receipt of any attachments at the time of opening the email

Your referees should also be asked to email their references to Ms Edney by the same deadline. We should accordingly be very grateful for your comments on this candidate's academic fitness and general suitability for the proposed course of study, and for any other information you consider relevant to this application. If you have knowledge of the candidate's recent study, it would be helpful if you could indicate the standard attained. Your comments will be treated in confidence by the Colleges.

Please email your reference directly to Ms Marion Edney. If a PA is sending this email on your behalf, please make it clear who the referee is. Please ensure that we can easily identify the correct candidate by inserting their name in the subject line of the email.
